ARTICLES OF INCORPORATION

THE UNDERSIGNED, ACTING AS INCORPORATOR[S] OF A CORPORATION PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT[S] THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III PURPOSE[S]

THE SPECIFIC PURPOSE[S] FOR WHICH THE CORPORATION IS ORGANIZED IS [ARE]:
