

**ARTICLES OF INCORPORATION OF
SOCIAL VENTURES FUND, INC.**

ARTICLE I. Corporate Name

The name of the Corporation is:

SOCIAL VENTURES FUND, INC.

ARTICLE II. Principal Office

The address of the principal office is:

ARTICLE III. Purposes

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Specifically, the Corporation will seek to identify social entrepreneurs who have sound ideas and sound financial plans to implement social ventures which introduce innovation and/or efficiency into a variety of public service programs, either existing or proposed; and will develop on its own and/or seek out innovative proposals for models or projects which have the potential for meaningful change in the way that social service and educational services and/or programs are delivered to the public.

ARTICLE IV. Manner of Election of Directors

The manner in which the directors are elected or appointed shall be stated in the bylaws.

ARTICLE V. Initial Directors

ARTICLE VI. Registered Office: Registered Agent

ARTICLE VII. The Name and Address of the Initial Incorporator

ARTICLE VIII. Dedication of Property

The property of this Corporation is irrevocably dedicated to the charitable purposes set forth above and no part of the net income or assets of this Corporation shall ever inure to the benefit of any trustee, or other officer, of this Corporation, or to the benefit of any private individual.

ARTICLE IX. Restrictions on the Corporation


For tax purposes, the Corporation shall operate subject to the following restrictions:

1. The Corporation shall distribute its income for each tax year at such time and in such manner as to not be subject to the tax on undistributed income imposed by Code Section 4942.
2. The Corporation shall not engage in any act of self-dealing as defined in Code Section 4941(d).
3. The Corporation shall not retain any excess business holdings as defined in Code Section 4043(c).
4. The Corporation shall not make any investments in such manner to subject it to tax under Code Section 4944.
5. The Corporation shall not make any taxable expenditures as defined in Code Section 4945(b).

ARTICLE X.

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision of payment, of all debts and liabilities of the Corporation, shall be distributed to such organization or organizations organized and operated exclusively for charitable purposes similar to those set forth in the third section above, and which has established its tax-exempt status under Code Section 501(c)(3), or corresponding provisions of any subsequent federal tax laws.



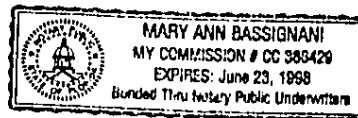
