

ARTICLES OF INCORPORATION

We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation not-for-profit, without capital stock, under the provisions of all applicable State of Florida Statutes. We hereby accept all the rights, priveleges, benefits and obligations conferred and imposed by said law, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I

NAME: FIRST PROVIDENCE MISSIONARY BAPTIST CHURCH FOUNDATION, INC.

ARTICLE II

PURPOSE: To provide Religious, Educational, Community Developement, Social Developement, and such skills as applicable to establishing moral character/social behavior traits. Aimed at becoming better law abiding citizens.

Serve as a community based center in providing a service in line with social programs; designed to improve the welfare of all persons living within said community.

ARTICLE III

TERM OF EXISTENCE: The term of existence of this corporation is perpetual.

ARTICLE IV

OFFICERS AND MANAGEMENT: The officers of this Not-For-Profit corporation shall be a President, Vice-President, Secretary, Treasurer. Management shall be vested in a Board of Directors consisting of at least seven (7) and no more than fifteen (15) directors. All officers; Treasurer, Secretary, and Directors will be appointed by President, or elected in accordane with the By-Laws.

ARTICLE V

ARTICLE VI

BY-LAWS: The By-Laws of the corporation shall be made, altered or rescinded by a majority vote of the Board of Directors; provided that notice thereof, which shall include the text of the By-Laws change, has been furnished in writing to each member of the Board at least ten (10) days prior to the meeting at which such By-Law alteration is to be voted upon.

The Articles of Incorporation of this corporation shall be amemded or additional provisions adopted by a two-thirds (2/3) vote of the members of the Board of Directors present. Provided that notice thereof, which shall include the text of the Articles of Incorporation change is to be voted upon, followed by the compliance with the Florida Statutes regarding amendments to Articles of Incorporation of corporations Not-For-Profit.

ARTICLE VII

GENERAL: Funding for this corporation shall be from various sources; Church generated funds, Government grants, Donations from private and business persons.

This corporation shall pay no dividends to its subscribers, officers, or members of any boards. In addition no part of the funds of the corporation shall be distributed to its directors, officers, or subscribers; provided that the corporation may pay compensation in a reasonable amount to its directors and officers for services rendered.
