ARTICLES OF INCORPORATION

FOR

HEALTHY ORGANIC PRODUCE & EDUCATION, INC.

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: HEALTHY ORGANIC PRODUCE & EDUCATION, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 882 Huntington Street, N.E., Palm Bay, Florida 32907.

ARTICLE III GENERAL AND SPECIFIC PURPOSES

- (a) The specific purposes for which this corporation is formed are to promote organic farming and gardening methods and to educate the public in the benefits of least toxic and least impact integrated pest managment and related topics.
- (b) The general purposes for which this corporation is formed are to operate exclusively for such charitable, scientific and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- (c) This corporation shall not, as a substantial part of its activaties, by propaganda, lobbying, or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.
