CERTIFICATE OF INCORPORATION

We, the undersigned, hereby associate ourselfs together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation, under the following proposed Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be The Friends of the Everglades, Inc. Broward County.

ARTICLE II

ADDRESS

The principal offices of this corporation shall be 5919 N.W. 65th Ave. Tamarac, Florida 33321.

ARTICLE III

OBJECTIVES

The purpose of this corporation shall be educational and informational, to increase public interest in and general knowledge of the whole region of the Everglades; to preserve its natural environment and promote its regional development in order to establish and maintain a beneficial and balanced life and water supply for all such peoples, cities, farms, suitable industries, the Everglades National Park, recreational, estuarial and wilderness areas that supply the natural and marine life to the surrounding salt water, in such proportion as South Florida can be expected to plan for and to support.

The Everglades region which shall be the concern of this association shall be understood to lie within the coastal limits of South Florida and include the fourteen or more counties containing, affecting and being affected by the supply, storage and flow of fresh water into and out of Lake Okeechobee into the Everglades; namely, Broward, Charlotte, Collier, Dade, Glades, Henry, Lee, Martin, Monroe, Okeechobee, Orange, Palm Beach and St. Lucie Counties.

ARTICLE IV

MEMBERS

Any person or association of good character and standing who of in agreement with the purposes of this corpotation shall be eligible to membership in the corporation, unless declared ineligible by the Board of Directors. The dues shall be fixed by the By-Laws.

ARTICLE V

TERM OF EXISTENCE

The term for which this association shall exist shall be perpetual or until dissolved according to law.
