ARTICLES OF INCORPORATION  
OF

FOUNTAINS OF FAITH MINISTRIES, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be Fountains of Faith Ministries, Inc., and the proposed place of business shall be 101 S. Sunset Dr., Casselberry, FL 32707.

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.

ARTICLE III

A. The purposes for which Fountains of Faith Ministries, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
