The undersigned, acting as incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes concerning not for profit organizations, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: **AQUILA MINISTRIES, INC.**

ARTICLE II

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III

This corporation is hereby organized for the following specific purposes:

To provide an institute which promotes and develops Christian Unity among churches; to establish a base of operation where communication between churches can exist; to provide an institute for Christian worship and provide an integrated approach to Christian education and personal growth and counseling within a distinctly Christian framework; to serve as a supplement to the educational and counseling ministries of churches in the community of churches; to bring together all five-fold ministries, including counselors, within a framework to make a greater impact on the Christian community; to serve as a research center to study issues affecting mental health and the spiritual health of the Christian community; to develop a resource network to provide speakers and counselors for churches and other related groups; and to develop a publication related to the Christian community and other like activities.

ARTICLE IV

The corporation will be run by a Board of Directors. The Board of Directors and the manner of election of said Board of Directors shall be further established within the By-Laws of the Corporation.

ARTICLE V

The corporate powers of this corporation will be as provided for in Section 617.0302 of the Florida Statutes concerning not for profit corporations.




