The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be:

PLEASANT GROVE BAPTIST CHURCH OF MAYO, FL. INC.

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III - Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

1. TO CARRY OUT THE GREAT COMMISSION OF THE GOSPEL AS STATED IN MATTHEW 28:19-20.
2. TO ADMINISTER THE ORDINANCES OF THE CHURCH, WHICH ARE: BAPTISM BY IMMERSION, AND THE LORDS SUPPER.
3. TO EDIFY THE SAINTS OF GOD BY THE WORD OF GOD.

ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed is as follows:
THE TRUSTEES SHALL BE ELECTED IN THE SAME MANNER IN WHICH THE DEACONS ARE ELECTED. THEY ARE TO BE RECOMMENDED TO THE CHURCH AND MUST RECEIVE A MAJORITY VOTE OF THE CONGREGATION. A TRUSTEE MAY SERVE A TERM UP TO THREE YEARS THEN MUST ROTATE OFF FOR AT LEAST TWELVE MONTHS BEFORE HE CAN COSIDERED FOR A TRUSTEE AGAIN.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:
THE TRUSTEES SHALL ASSIST THE PASTOR IN THE GENERAL WELFARE OF THE THE CHURCH. THE TRUSTEES WILL NOT HAVE ANY ACTING POWER EXCEPT THAT OF A REGULAR CHURCH MEMBER
