ARTICLE I

The name of the corporation shall be The Apollo Beach Track Club, Inc.

ARTICLE II

The business address of the corporation shall be 413 Flamingo Drive, Apollo Beach, Florida 33572.

ARTICLE III

The purpose of the corporation shall be that of a track club open to everyone between the ages of 8 and 16 in Apollo Beach and the surrounding area. Members train to compete in local track meets and the Hershey Track and Field Competition, as well as any other track meet in which the club desires to compete. The track club is a program offered through the Hillsborough Parks and Recreation Department and sponsored by local business, individuals, parents, and the athletes. The track club is coached and administered by volunteers.

The intent of the club is to teach youngsters how to train and compete in the sport of track and field and to teach the athletes how to set and attain goals while working with others. Athletes also learn that being the best you can be is what makes you a winner.

The Apollo Beach Track Club, Inc. shall be a Corporation Not For Profit as enunciated in Chapter 617 of the Florida Statutes, 1993, as amended.

ARTICLE IV

The directors of this corporation shall be elected annually by the corporate officers.

ARTICLE V

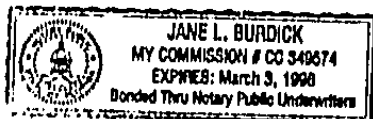
