

ARTICLES OF AMENDMENTS
to
ARTICLES OF INCORPORATION
of

REV. BENJAMIN GRIFFIN KIDNEY RESEARCH & TREATMENT FUND, INC.
A Florida Not-For-Profit Corporation

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendments Adopted:

ARTICLE III.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to fund research and treatment of kidney disease.

The purpose for which the corporation is organized are exclusively charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE VIII.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, of the county in which the principal office of the corporation is then located, exclusively for such purposes.


SECOND:

The date of adoption of these articles of amendment was October 3, 1995.

THIRD:

There are no members or members entitled to vote on the amendments. These articles of amendments was adopted by the Board of Directors.
