The undersigned, acting as an incorporator of a Corporation pursuant to the Florida Not-for-Profit Corporation Act, adopts the following ARTICLES OF INCORPORATION for such Corporation:

### ARTICLE ONE

The name of the Corporation is:

ARTICLE EIGHT




