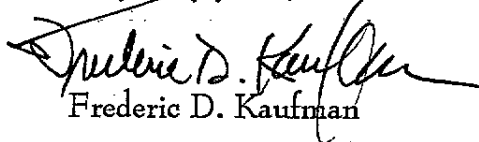

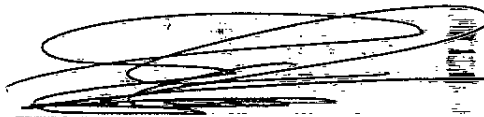
FIRST: Amendment adopted: Article 1 is hereby amended as follows:
