- FIRST: THE CORPORATE NAME THAT SATISFIES THE REQUIREMENTS OF SECTION 617.0401 IS:  
Durr Music School of the Arts, Inc.
- SECOND: THE PURPOSE(S) FOR WHICH THE CORPORATION IS ORGANIZED IS:  
Non-profit school of arts
- THIRD: THE ADDRESS OF THE PRINCIPAL OFFICE, IF KNOWN, AND THE MAILING ADDRESS OF THE CORPORATION IS: 4360 Northlake Blvd., Suite 205
