ARTICLES OF INCORPORATION  
OF  
FLORIDA FUTURE YOUTHS INCORPORATED

**Article 1. Name.** The name of the Corporation is: **FLORIDA FUTURE YOUTHS INCORPORATED**

**Article 2. Duration.** The duration of the Corporation is perpetual.

**Article 3. Purposes.** The purpose of the Corporation is as follows:

- A - This corporation is a not-for-profit corporation organized under Chapter 617, Florida statutes. It is not organized for the private gain of any singular person. The specific purposes of this corporation are: \_\_\_\_\_
- 1- To provide job skill training with the newspaper, and other products, learn to read program, crime prevention, community involvement with youths of and for any youth(s) who are underprivileged, troubled, disadvantaged, physically, and / or mentally disabled.
  - 2- To hire and employ person (s) to perform the service (s) that are described in Article 3-Paragraph-A (1).
  - 3- To assist in the education and/or training of person (s) needed for employment and/or to perform the service (s) of Article 3-Paragraph-A (1).
- B - To exercise all rights and powers conferred by the laws of the state of Florida upon nonprofit corporations.
- C - Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to benefit of or be distributable to its members, directors, or officers: but the corporation shall be authorized and empowered to pay reasonable compensation and distributions in furtherance of its stated purposes.

**Article 4. Members.** The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting members of one or more classes, who shall be admitted in Bylaws, but who shall not have the right to vote. The names and addresses of each initial Voting Member is listed in the Bylaws.

**Article 5. Initial Registered Agent and Office.** The initial registered agent is Douglas L. Nelson, and the initial registered office is 4575 Moncrief Rd., Jax, FL.

**Article 6. Initial Board of Directors.** The initial Board of Directors shall have 3 members whose names and addresses are listed in the Bylaws.

**Article 7. Officers.** The officers of the Corporation shall consist of a President, Vice-President, Secretary, Treasurer. Other officers may be provided for in the Bylaws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. The names and addresses of each initial Officer of the Corporation is listed in the Bylaws.

**Article 8. Nonstock Basis.** This Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the Bylaws.

#### ARTICLE 9. FISCAL YEAR

The fiscal year of the Corporation shall be the period selected by the Board of Directors as the taxable year of the Corporation for federal income tax purposes.

#### ARTICLE 10. SEAL

The Corporate seal shall bear the name of the Corporation to the left of a globe of the earth, and two children playing.

#### ARTICLE 11. INDEMNIFICATION

The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by the Florida General Corporation Act and the Florida Not For Profit Corporation Act.

#### ARTICLE 12. AMENDMENTS

The amendments may be altered, amended, or replaced, and new amendments may be adopted by the Board of Directors; provided, however, that any articles or amendments thereto as adopted by the Board of Directors may be altered, amended, or repealed by vote of the Members; or a new Bylaw in lieu thereof may be adopted by the Members. No amendments which has been altered, amended, repealed, or adopted by such vote of the Members may be altered, amended, repealed by vote of the Board of Directors for a period of two (2) years after the action of the Members.
