# ARTICLES OF INCORPORATION OF MARING A PROGRESSIVE STEP FOUNDATION, INC.

#### KNOW ALL MEN BY THESE PRESENTS:

That (We), the undersigned, dering to form a Non-Profit Corporation under and purguant to the laws of the State of Florida, and for that purpose, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I

NAME: The name of the corporation is MAKING A PROGRESSIVE STEP FOUNDATION, INC.

DURATION: The duration of the Corporation is perpetual.

#### ARTICLE III

FURPOSES: The purpose of the corporation is as follows:
