ARTICLES OF INCORPORATION

OF

Paralogal Association of Florida, Inc. A Corporation Not for Profit

The undersigned incorporator, for the purpose of forming a corporation under the laws of Florida, hereby, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: Paralegal Association of Florida, The.

The principal place of business of this corporation shall be: 1525 S. Andrews Avenue, Suite 216, Fort Lauderdale, FL 33316.

ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of operating as a not for profit company, specifically, to promote and maintain high standards in the paralegal profession; to foster expansion of the paralegal career; to offer and encourage continuing education for paralegals; to provide a forum for meeting and exchanging ideas; to establish and maintain mutually beneficial working relationships with local, state, and national bar associations and paralegals; and to inform members of developments in the paralegal profession.
