2. To provide affordable housing for: (1) low to moderate income individuals, (2) for the homeless individuals and families with children and, (3) handicapped persons.

3. The foregoing purposes and activities are examples only and not limitations. Nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful purposes which may become necessary or desirable for the furtherance of the corporate objectives set forth above.

Generally, to carry out any act that is not inconsistent with the corporation laws of the State of Florida, and to have and exercise all rights and powers conferred on non-profit corporations under Florida law, as such law is now in effect or may at any time hereafter be amended.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

The corporate powers of this corporation are as provided in section 017.0302, Florida Statutes, unless limited as follows:
