Pursuant to its Application for Recognition of Exemption under Section 501(c)(3) of the Internal Revenue Code, South Florida Medical Digests, Inc. hereby issues the following Amendments to its original Articles of Incorporation:

ADDING THE FOLLOWING TO ARTICLE THE

A. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(e)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ADDING THE FOLLOWING TO ARTICLE X:

B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ADDING THE POLICYING TO ARTICLE XI:

C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(e)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

These amendments to the Articles of Incorporation were presented to and unanimously voted by all the existing members & directors of the South Florida Medical Digests, Inc. at an emergency meeting on May 31, 1996, held specifically for that purpose.
