ARTICLES OF INCORPORATION OF
DARLINGTON OAK GROVE BAPTIST CHURCH, INCORPORATED

Pursuant to Chapter 617, Florida Statutes, the undersigned, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is DARLINGTON OAK GROVE BAPTIST CHURCH, INCORPORATED.

ARTICLE TWO
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE
PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To do any act, including acquire, lease and otherwise hold real and or personal property for the purpose of promoting and facilitating the ministries of the Darlington Oak Grove Baptist Church and to promote the Gospel of Jesus Christ in the world.

2. To transact any other lawful business for which corporations may be incorporated under the Florida Not For Profit Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
