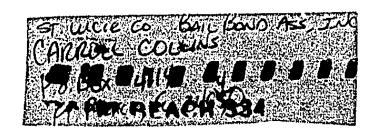

ARTICLES OF INCORPORATION

OF

ST. LUCIE COUNTY BALLBOND ASSOCIATION, INC. a corporation not-for profit

We, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE_I

NAME

The name of the corporation is ST. LUCIE ' UNTY BAILBOND ASSOCIATION, INC.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III PURPOSE

The general nature of the business of the corporation and the objects or purposes to be transacted, promoted or carried on by the corporation are as follows: to promote fellowship through the organization of locally owned and operated bailbond businesses within the boundaries of St. Lucie County.
