**Articles of Incorporation  
of  
Praise Tabernacle Outreach Center, Inc.**

**First:** The name of the Corporation is Praise Tabernacle Outreach Center, Inc.

**Second:** The named Corporation's registered office in the State of Florida is to be located at 1860 SW 37th Way, City of Fort Lauderdale, County of Broward. The registered agent in charge thereof is Dolores Bright at 1860 SW 37th Way, Fort Lauderdale, Florida, 33312. The principal office address is the same as the address of the registered office and agent's.

**Third:** The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the world.

"The purpose of the corporation is to engage in any lawful act of activities for which the corporation may be organized, under the general Corporation Law of Florida. More specifically, for the deepening of spiritual lives among ourselves, thereby enabling us to impress every Christian experience possible in this life according to Matthew 5;13-16. Our purpose is to ordain Pastors, Evangelists, Teachers, Deacons and Elders for the perfecting of the saints (the body of Christ), to administer the Lord's Supper, Feet Washing as administered by Christ and the Holy Apostles, according to I Corinthians 12 and St. John 13. Our purpose is to perform marriage ceremonies, bury the dead, and to better control the church and it's affairs. Our purpose is to extend charity, to stimulate education, to fight wickedness for the uplifting of mankind, to go out and on and win souls for Christ.

- A. Notwithstanding any other provisions of these Articles, the purpose for which this organization is organized are exclusively religious, charitable, scientific, literary and educational, within the meaning of section 501-C3, of the Internal Revenue Code currently enforced, or any corresponding provision of any future United States Internal Revenue Law.
- B. Notwithstanding any other other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501-C3 of the current Internal Revenue Code, or the corresponding provision of future United States Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations described in section 501-C3 of the current Internal Revenue Code or to the Federal , State or Local government for public purpose exclusively.

Fourth: The manner in which the directors are elected or appointed are done in accordance to the procedures as set forth in Article VI of the corporate bylaws.
