Articles of Incorporation of Praise Tabernacie Outreach Center, Inc.

First: The name of the Corporation is Praise Tabernacle Outreach Center, Inc.

Third: The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do, and in any part of the world.

Notwithstanding any other other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501-C3 of the current Internal Revenue Code, or the corresponding provision of future United States Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations described in section 501-C3 of the current Internal Revenue Code or to the Federal, State or Local government for public purpose exclusively.
