The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes adopts the following Articles of Incorportation;

#### Article I Name

As stated herein the Articles of Incorporation, the name of the corporate ministries shall be Florida Faith Ministries International, Inc.

## Article II

The principal place of ministry shall be Safety Harbor Florida, and the mailing address of the corporation is Post Office Box 896, Safety Harbor, Florida 34695-0896.

## Article III Purposes

The specific purposes for which Florida Faith Ministries International, Inc. is organized for are:

#### Our Master Plan

It is the vision of Florida Faith Ministries International, Inc. to establish a network of ministries, agencies and opportunities to provide for *restoring*, *encouraging*, *equipping*, and *producing* of quality world-class Christians to impact every sphere of human experience. To accomplish this vision, Florida Faith Ministries International, Inc. will consists of a multi-faceted network of ministries functioning through the following agency:

#### Section 1. A Church

The establishment and continual development of a continual, vibrant, charismatic, Christ-centered, family focused church fellowship designed to provide opportunities for personal spiritual growth and development, discipleship and corporate praise, prayer and worship experiences with strong emphasis on teaching practical biblical Kingdom principles for successful and victorious daily living. This local church fellowship will serve as the human resource arm for developing leaders to serve in all other facets of the ministry's vision.

## Article IV Manner of election of directors

The Board of Directors is hereinafter referred to as the Executive Board (or Members of the Executive Board).

<u>Section 1</u>. The founder of Florida Faith Ministries International, Inc. shall be the initial president and chairman of the Executive Board of Florida Faith Ministries International, Inc.

Section 2. The manner in which the directors are elected or appointed is as follows: Executive Board Members shall be appointed by the President of Florida Faith Ministries International, Inc. during the first year of operation. Then thereafter the members shall be nominated by the executive board and affirmed by the members of Florida Faith Ministries International, Inc.

## Article V Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.



Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Cod of 1986 or the corresponding provision of any future United States Internal Revenue law

#### Article IX Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state of local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
