## ARTICLES OF INCORPORATION OF PROVIDENCIA PARK BUSINESS ASSOCIATION, INC.

The undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation:

### ARTICLE I Name of Corporation

The name of this Corporation shall be PROVIDENCIA PARK BUSINESS ASSOCIATION, INC.

### ARTICLE II Purposes

The purpose for which this Corporation is organized is to provide social and economic betterment for the area of Providencia Park being defined as between Flagler and Railroad Avenue east and west and 7th Street and 15th Street north and south, each inclusive.

#### ARTICLE III Prohibited Activities

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable, to its members, trustees, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

### ARTICLE IY Membership, Qualification and Admission

The qualification of members, the manner of their admission and voting of members shall be as follows:

Section 1. Voting Members: Qualifications. Any person owning a business or realty in the aforesaid area including corporations shall be eligible for membership. All joint owners of real property shall be equally entitled to membership so long as they reside on or conduct business upon the realty. Non-residing or non-business conducting joint owners shall have one vote for the membership.

Section 2. Non-voting Members: Qualifications. Any natural person who is a resident occupant or tenant in the aforesaid area who does not qualify as a voting member.

<u>Section 3</u>. Election of Members. Election of members shall be by the Board of Directors, and upon the affirmative vote of at least a majority of the Board members present and voting, a person shall be entitled to membership in this Corporation.

Section 4. Voting Rights. Voting rights of members shall be in accordance with the provisions of the Bylaws of this Corporation.

### ARTICLE V Corporate Duration

This Corporation shall have perpetual existence unless sooner dissolved by law.

#### ARTICLE VI Principal Office, Initial Registered Office and Agent

The street address of the principal office and initial registered office of this Corporation is 1000 N. Dixie, West Palm Beach, Florida 33401, and the name of the initial registered agent of this Corporation at such address is WILLIAM PEARL.

#### ARTICLE VII Board of Directors

This Corporation shall have four (4) Directors initially. The number of Directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3). The names and addresses of the initial Directors of this Corporation, who shall serve until their successors are elected or appointed and have qualified, in accordance with the Bylaws are:

### ARTICLE VIII Amendment to Articles of Incorporation and Bylaws

These Articles of Incorporation and the Bylaws of the corporation may be amended by the Board of Directors adopting a resolution at any regular or special meeting of the Board of Directors setting forth the proposed amendment, which shall be submitted to a vote at a meeting of the members, which may be either the annual or a special meeting. After proper written notice for a meeting and written notice setting forth the proposed amendment is given to the members, at such meeting, the amendment shall be adopted upon receiving the affirmative vote of two-thirds of the votes of members present physically or by proxy, pursuant to the Bylaws of this corporation.

#### ARTICLE IX Indemnification

Every Director and every officer of this Corporation shall be indemnified by this Corporation to the full extent permitted by law against all expenses and liabilities, including attorney's fees in trial and appellate proceedings, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party, or in which he may become involved, by reason of his being or having been a Director or officer of this Corporation, or any settlement thereof, whether or not he is a Director or officer at the time such expenses are incurred unless the liability of the Director of officer in question is adjudged by decision of court to result from the gross negligence or willful misconduct of such officer or Director in the performance of his duties; provided, however, that in the event of a settlement, the indemnification herein shall apply only when the Board of Directors approves such settlement and reimbursement as being in the best interest of this Corporation. The foregoing right of indemnification shall be in addition to and shall not be in addition to and shall not be exclusive of all other rights to which said Director or officer may be entitled.


