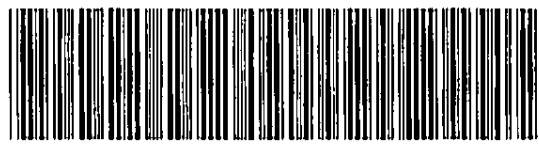

“ARTICLE VI

BYLAWS

6.1 The By-Laws of the Association may be [*made, altered or rescinded*] **amended** at any annual meeting of the Association, or at special meeting duly called for such purpose, on the affirmative vote, **in person or by proxy**, of a majority of the class of Members entitled to vote at that time, [*present in person or by proxy at such meeting.*] **PROVIDED THAT notice of the proposed amendment, including the purpose of the amendment and the specific wording of the amendment approved, was distributed to all of the members with the notice of that meeting.***[except that the initial Bylaws of the Association shall be made and adopted by the Board of Directors.]*

ARTICLE VII

AMENDMENTS

7.1 Amendments to these Articles of Incorporation may be proposed by any member of the Association. These Articles may be amended at any annual meeting of the Association, or at any special meeting duly called for such purpose, on the affirmative vote of a majority of the number of total votes of the Membership entitled to vote at the time of such meeting, **PROVIDED THAT notice of the proposed amendment, including the purpose of the amendment and the specific wording of the amendment approved, was distributed to all of the members with the notice of that meeting.”**
