The undersigned, acting as Incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

### ARTICLE I

### ARTICLE II

The period of the duration of this corporation is  
unless dissolved according to law. Perpetual. Commencing with filing with the  
Secretary of State.

### ARTICLE III

The purpose (purposes) for which the corporation is organized is (are): The purposes for which the corporation is organized are exclusively for religious, charitable, scientific, literary and education within the meaning of section 501 (s) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

### ARTICLE IV

The qualifications for members and the manner of their admission are: Membership shall consist of any interested citizen of Broward County, Florida (hereinafter referred to as "County"), business and/or property owners, and annual membership fee.

Only financial members shall have voting privileges. Financial members shall be those who pay the annual membership fee as set by the Board of Directors.

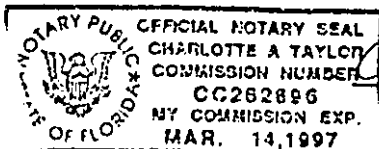
