The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

- A. TO PROMOTE AND ENCOURAGE PARTICIPATION OF THE DEAF COMMUNITY AND SUPPORTERS IN ALL ASPECTS OF COMMUNITY ACTIVITIES INCLUDING FUND-RAISING TO SUPPORT THE OBJECTIVES. B. TO EXERCISE ALL RIGHTS AND POWERS CONFERRED BY THE LAWS OF THE STATE OF FLORIDA UPON NONPROFIT CORPORATIONS. C. PROVIDED, HOWEVER, THAT THE CORPORATION SHALL NOT ENGAGE IN ANY ACTION WHICH IS NOT PERMITTED TO BE CARRIED ON BY A NONPROFIT CORPORATION UNDER THE INTERNAL REVENUE CODE AND NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO ITS MEMBERS, DIRECTORS, OR OFFICERS; BUT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION TO THESE PEOPLE FOR SERVICES RENDERED, AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF ITS STATED PURPOSES.

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

ELECTED BY THE MEMBERS OF THE ORGANIZATION AT ANNUAL MEETING.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:

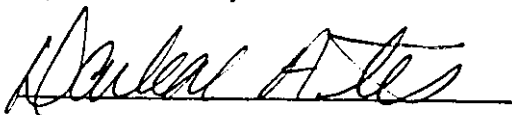
