- ARTICLE I. The name of this corporation not for profit shall be: Miracle Crusade Ministries, Inc.
- ARTICLE II. The principle place of business and mailing address of this corporation shall be:

- ARTICLE III. The specific purposes for which this corporation is organized are for evangelistic outreaches, revivals, and crusades; Bible courses, conferences, and seminars; tithes, offerings, and fund raising; recreation; religious courses; vehicles and all other modes of transportation to carry members and non-members to and from religious meeting places and events; issuing lawful marriage certificates to members and non-members; bury it dead members and non-members; give diplomas, licenses, and ordinations to qualified students; preaching the gospel of Jesus Christ for repentance, divine heling, deliverance and gifts of prophecy; believing in and ministering in God's inspired word in the whole sixty-six books of the Bible; continuing in religious prayer for the preaching of the gospel.
