BREVARD PROFESSIONAL NETWORK, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, and its Articles of Incorporation, as amended, Brevard Professional Network, Inc. adopts the following amendment to its Articles of Incorporation, as originally filed with the Secretary of State of the State of Florida on June 26, 1995, as amended on January 12, 1998, July 29, 2002 and April 4, 2012. *19500003064*

ARTICLE X – MEMBERS

- (a) Membership in the corporation shall be divided into three (3) classes: Physician members, affiliate members and associate members.
- (b) Physician membership shall consist solely of doctors of medicine licensed under Chapter 458, Fla. Stat., doctors of osteopathy licensed under Chapter 459, Fla. Stat., doctors of dentistry, licensed under Chapter 466, Fla. Stat., doctors of chiropractic licensed under Chapter 460, Fla. Stat., doctors of podiatry, licensed under Chapter 461, Fla. Stat., and psychologists, licensed under Chapter 490, Fla. Stat. Physician members must have an active board certification or be eligible to sit for the board within 5 years after the completion of residency or fellowship training, whichever is the highest level of training completed.
- (c) The term "physician" as used in these Articles, shall refer to the person described in paragraph (b) of this Article X.
- (d) Affiliate members shall consist solely of doctors of medicine licensed under Chapter 458, Fla. Stat., doctors of osteopathy licensed under Chapter 459, Fla. Stat., doctors of dentistry, licensed under Chapter 466, Fla. Stat., doctors of chiropractic licensed under Chapter 460, Fla. Stat., doctors of podiatry, licensed under Chapter 461, Fla. Stat., and psychologists, licensed under Chapter 490, Fla. Stat.
- (e) Associate membership shall consist solely of advanced registered nurse practitioners, licensed and certified under Chapter 464, Fla. Stat., physician assistants licensed and certified pursuant to Section 458.347 Fla. Stat., or 459.022 Fla. Stat., midwives licensed and certified pursuant to Chapter 467, Fla. Stat., or any other individual who, as the Board of Directors may determine by specific provision therefor in the Bylaws, exercises

independent judgment within the areas of his or her professional competence and who is qualified to render direct or indirect medical, dental, podiatric, surgical, or psychological care under the supervision of a physician. An associate member must work under the supervision of a physician member. Loss of membership by a physician member shall cause the immediate termination of any associate member under the supervision of the physician member.

- (f) Voting rights of members, other than as stated in these Articles of Incorporation, shall be stated in the bylaws.

The Amendment to the Articles of Incorporation of the corporation was adopted and approved by a unanimous vote of the Board of Directors of the corporation. There are no members entitled to vote on the amendment.
