ARTICLES OF INCORPORATION  
OF  
RECOVERY HOUSING FOR THE BETTERMENT OF THE COMMUNITY, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons, competent contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be RECOVERY HOUSING FOR THE BETTERMENT OF THE COMMUNITY, INC., a Florida Corporation not for profit.

ARTICLE II - DURATION

The term of the existence of the corporation is perpetual.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to provide Housing for the indigenet, the Homeless, the Addicted, those with HIV Positive and with AIDS, in the local community, and to conduct any other lawful business in connection therewith and are exclusively religious and charitable, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law.

This corporation shall issue no stock. No part of the net earnings of this corporation shall be distributable to its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in this article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation.. This corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue Law.

In the event of dissolution of this corporation, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local Government for exclusive public purpose.

#### ARTICLE IV - MEMBERS

The qualifications for members and the manner of their admissions shall be prescribed in the By-Laws of the corporation from time to time.

#### ARTICLE V - REGISTERED OFFICE AND AGENT

The initial registered office of the corporation shall be 521 South Federal Highway, Lake Worth, Florida and the name of the initial registered agent of the corporation at that address is John G. Keefe. The mailing address shall be the same as the registered office address.

#### ARTICLE VI - DIRECTORS

This corporation shall have a Board of Directors of <sup>Three (3)</sup> ~~two (2)~~ directors, initially. The number of directors shall be prescribed in the By-Laws from time to time. The names and addresses of the directors who shall serve until the first election are:

Section 215.26 states, in part: "Application for refund as provided by this section shall be filed with the Comptroller, except as otherwise provided herein, within 3 years after the right to such refund shall have accrued else such right shall be barred."
