Pursuant to the provisions of FSA † 617.1001 and 617.1002, this corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation before and after this amendment remains Florida Association of Health Plans, Inc.
- 2. The following provisions of the Articles of Incorporation of Florida Association of Health Plans, Inc., a Florida corporation, filed in Tallahassee on June 27, 1995, as amended by Articles of Merger, filed on November 1, 2000 be and they hereby are amended in the following particulars:

C). Article X – "Officers" section 10.1 be and it hereby is amended in its entirety to read as follows:

"The officers of the Board shall be as set forth in the Corporation's Bylaws."

Each of the above amendments were adopted by the board of directors adopting a resolution, on 10/23, 2007 setting forth the proposed amendment and submitting such resolution to a vote at a meeting of director/members entitled to vote on the proposed amendment at the 2007 annual meeting of the Corporation. The above amendments were adopted upon receiving at least a majority of the votes which members/directors present at such annual meeting.
