ARTICLES OF INCORPORATION FOR FAITH CENTER TABERNACLE, INC.

WE THE UNDERASSIGNED, DESIRING TO ASSOCIATE, FOR THE PURPOSE OF INCORPORATING, AS A CORPORATION, NOT FOR PROFIT, UNDER THE PROVISIONS OF CHAPTER 617 OF THE FLORIDA STATUTES, AND AS RECOGNIZED UNDER SECTION 501(c) (J) OF THE INTERNAL REVENT E CODE, DO HEREBY PROPOSE THE FOLLOWING AS OUR ARTICLES OF INCORPORATION.

ARTICLET

THE NAME OF THE CHURCH SHAUL BE, FAITH CLNTER TABERNACLE, INC. 3406 MOUNTAIN LAKE CUT-OFF ROAD, LAKE WALES, POLK COUNTY FLORIDA

ARTICLE II

THE PURPOSE OF FAITH CENTER TABERNACLE, INC. IS TO ESTABLISH AND MAINTAIN NON-DENOMINATION ALCOMMUNITY CHURHCES AS PLACES OF WORSHIP FOR THOSE THAT DESIRE THE RIGHT HAND FELLOWSHIP, TO BUILD AND MAINTAIN AUMISTIC BODY OF PERSONS WHO BELIEVE IN THE TEACHINGS OF OUR LORD JESUS CHRIST. AND ADHERE TO THE FAITH TO BETTEE PROMOTE AND PROPAGATE THE GOSPEL OF OUR LORD JESUS CHRIST.

THE CORPORATION IS FORMED FOR LAWFUL NONPROFIT PURPOSTS AND OBJECTIVES. NO STOCK OR SECURITIES WILL BE ISSUED.
