ARTICLES OF INCORPORATION FOR FAITH CENTER TABERNACLE, INC.

WE THE UNDERASSIGNED, DESIRING TO ASSOCIATE, FOR THE PURPOSE OF INCORPORATING, AS A CORPORATION, NOT FOR PROFIT, UNDER THE PROVISIONS OF CHAPTER 617 OF THE FLORIDA STATUTES, AND AS RECOGNIZED UNDER SECTION 501(c) (3) OF THE INTERNAL REVENUE CODE, DO HEREBY PROPOSE THE FOLLOWING AS OUR ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THE CHURCH SHALL BE, FAITH CENTER TABERNACLE, INC.
5406 MOUNTAIN LAKE CUT-OFF ROAD, LAKE WALFIS, POLK COUNTY, FLORIDA

ARTICLE II

THE PURPOSE OF FAITH CENTER TABERNACLE, INC. IS TO ESTABLISH AND MAINTAIN NON-DENOMINATIONAL COMMUNITY CHURCHES AS PLACES OF WORSHIP FOR THOSE THAT DESIRE THE RIGHT HAND FELLOWSHIP, TO BUILD AND MAINTAIN A UNIFIED BODY OF PERSONS WHO BELIEVE IN THE TEACHINGS OF OUR LORD JESUS CHRIST AND ADHERE TO THE FAITH TO BETTER, PROMOTE AND PROPAGATE THE GOSPEL OF OUR LORD JESUS CHRIST

THE CORPORATION IS FORMED FOR LAWFUL NONPROFIT PURPOSES AND OBJECTIVES. NO STOCK OR SECURITIES WILL BE ISSUED. ALL CORPORATE ASSETS WILL BE DEDICATED TO EXEMPT PURPOSES, ALTHOUGH THE CORPORATION WILL BE AUTHORIZED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED, AND TO ENTER INTO BUSINESS TRANSACTIONS IN FURTHERANCE OF ITS EXEMPT PURPOSE. THE CORPORATION WILL NOT PAY DIVIDENDS, AND ITS ASSETS WILL NOT INURE TO THE PRIVATE PROFIT OF ANY PERSON.

IF AND WHEN THE CORPORATION IS DESOLVED, ITS ASSETS WILL BE DISTRIBUTED FOR EXEMPT PURPOSES, OR WILL DEVOLVE TO A GOVERNMENT AGENCY FOR A PUBLIC PURPOSE. NONE OF THE ASSETS WILL BE DISTRIBUTED TO PRIVATE INDIVIDUALS.

ARTICLE III

THE PERSON, OR PERSONS DESIRING TO BE FELLOWSHIPEE INTO FAITH CENTER TABERNACLE, INC. SHALL BE SAVED, FILLED WITH THE HOLY GHOST, OR SEEKING THE HOLY GHOST, AND HAS MADE A VERBAL COMMITMENT TO OUR LORD JESUS CHRIST.

ARTICLE IV

FAITH CENTER TABERNACLE, INC. SHALL HAVE PERPETUAL EXISTENCE, EXCEPT SOONER DISSOLVED BY LAW.

ARTICLE V

THE SUBSCRIBERS OF THE ARTICLES OF INCORPORATION OF FAITH CENTER TABERNACLE, INC. ARE AS FOLLOWS:

ARTICLE VI

THE BUSINESS TRANSACTIONS OF FAITH CENTER TABERNACLE, INC. ARE TO BE MANAGED BY THE CHAIRMAN OF THE BOARD, TREASURER, AND SECRETARY, AND SUCH OTHER OFFICERS AS MAY BE APPOINTED. ALL OFFICERS SHALL BE APPOINTED BY THE CHAIRMAN OF THE BOARD.

THE OFFICERS OF THE CORPORATION WILL NOT BE PERSONALLY LIABLE FOR THE CORPORATION'S DEBTS AND LIABILITIES, AND THEIR PERSONAL PROPERTY IS EXEMPT FROM SEIZURE OR LEVY TO PAY OBLIGATIONS OF THE CORPORATION.

THE CHAIRMAN OF THE BOARD SHALL SIGN ALL CHECKS AND DOCUMENTS ALONG WITH SUCH OTHER OFFICERS AS MAY BE APPOINTED.

ARTICLE VII

THE FIRST BOARD SHALL CONSIST OF INDIVIDUALS WHOSE NAMES AND ADDRESSES ARE AS FOLLOWS:

ARTICLE VIII

THE ABOVE NAMED OFFICERS ARE TO SERVE AS THE BOARD UNTIL WHICH TIME THEIR SUCCESSORS ARE APPOINTED.

ARTICLE IX

THE BYLAWS OF FAITH CENTER TABERNACLE, INC. ARE TO BE MADE BY THE CHAIRMAN OF THE BOARD AND MAY BE ALTERED OR REPEALED BY A UNANIMOUS VOTE OF THE BOARD OF TRUSTEES.

ARTICLE X

ANY AMENDMENT TO THESE ARTICLES OF INCORPORATION SHALL BE PROPOSED BY THE CHAIRMAN OF THE BOARD AND SHALL BE ADOPTED BY AN AFFIRMATIVE TWO-THIRDS VOTE OF THE BOARD OF TRUSTEES AT THEIR QUARTERLY BUSINESS MEETING.

ARTICLE XI

THE PASTOR OF THE CHURCH SHALL BE THE CHAIRMAN OF THE BOARD AND SHALL REMAIN IN OFFICE AS LONG AS HE/SHE SHALL LIVE AND CAN ONLY BE REMOVED FROM OFFICE FOR MISCONDUCT, TEACHING FALSE DOCTRINE OR IMMORALITY. EACH MEMBER OF THE BOARD OF TRUSTEES SHALL BE APPOINTED BY THE CHAIRMAN OF THE BOARD AND SHALL SERVE AS LONG AS HE/SHE IS IN COMPLETE AGREEMENT WITH THE ARTICLES OF INCORPORATION OF FAITH CENTER TABERNACLE, INC.

ARTICLE XII

SHOULD ANY MEMBER OF THE BOARD OF TRUSTEES OR ANY OFFICER OF FAITH CENTER TABERNACLE, INC., BE PROVEN GUILTY OF IMMORALITY OR SHALL IN PART FROM THE FAITH THEY SHALL BE IMMEDIATELY REMOVED FROM THEIR POSITION IN THE CHURCH

ARTICLE XIII

THE CHAIRMAN OF THE BOARD OF TRUSTEES, AKA PASTOR, SHALL HAVE THE RIGHT TO VETO ANY ACTION TAKEN OR PROPOSED TO BE TAKEN BY THE BOARD IF IN HIS HER OPINION SUCH ACTION OR PROPOSED ACTIONS ARE EMINENTLY TO THE TEACHINGS OF FAITH CENTER TABERNACLE, INC. OR OTHERWISE CONTRARY TO THE BEST INTERESTS OF THE CORPORATION.

ARTICLE XIV

THE ARTICLES OF INCORPORATION OF FAITH CENTER TABERNACLE, INC. ARE FOR THE PURPOSE OF OWNING PROPERTY, TRANSACTING ITS BUSINESS, AND ALSO TO DIRECT ITS OFFICERS IN THE GOVERNING OF THE LOCAL BODY OF THE CHURCH.

ARTICLE XV

AT ALL TIMES, THE ORGANIZATION'S INVESTMENTS AND INVESTMENT POLICY WILL BE CONSISTENT WITH ITS NONPROFIT PURPOSE, AND INCOME AND ASSETS WILL BE GENERATED ONLY TO CARRY OUT THE NONPROFIT PURPOSE, NOT TO GENERATE A PROFIT FOR ANY PERSON OR ORGANIZATION.

THE POWERS OF THE CORPORATION WILL INCLUDE ALL POWERS GRANTED BY THE STATE OF FLORIDA TO NONPROFIT ORGANIZATIONS OF THE SAME TYPE. IN ADDITION, THE CORPORATION'S POWERS WILL INCLUDE THE FOLLOWING, TO THE EXTENT NOT TO BE PROHIBITED BY STATE OR FEDERAL LAW:

- A. TO SOLICIT, COLLECT, RECEIVE, HOLD, INVEST, DISTRIBUTE, AND DISBURSE FUNDS IN THE FORMS OF DONATIONS, GIFTS, BEQUESTS, AND SUBSCRIPTIONS.
- B. THE POWER TO ACCEPT GIFTS FROM INDIVIDUALS, CORPORATIONS AND FOUNDATIONS IN FURTHERANCE OF THE CORPORATION'S NONPROFIT PURPOSE.
- C. TO BORROW FUNDS WITH OR WITHOUT SECURITY, WITH TERMS AT LEAST AS FAVORABLE ON THE OPEN MARKET, TO CARRY OUT THE CORPORATION'S NONPROFIT PURPOSE, AS AUTHORIZED BY TWO-THIRD VOTE OF THE BOARD OF TRUSTEES AND AS APPROVED BY THE STATE'S REGULATORS OF CHARITABLE ORGANIZATIONS.
- D. THE POWER TO ENGAGE IN FUND-RAISING EVENTS FOR EXAMPLE, BENEFITS AND SALES OF DONATED MERCHANDISE, PROVIDED THAT THESE EVENTS ARE INFREQUENT AND IRREGULAR, NON-TASTAMOUNTFUL, MAINTAINANCE OF A PROFIT-MAKING BUSINESS, AND PROVIDED THAT THE INCOME DERIVED FROM THESE EVENTS, NET OF REASONABLE EXPENSES, WILL BE ENTIRELY DEVOTED TO THE ORGANIZATION'S NONPROFIT PURPOSE.
- E. THE POWER TO ORDAIN AND LICENSE MINISTERS OF THE GOSPEL.
- F. THE POWER TO GRANT A CHARTER TO AND ORGANIZE CHURCHES AND CHURCHES TO ESTABLISH MULTIPLE BODIES OF BELIEVERS.
- G. TO ESTABLISH LEARNING FACILITIES, HELP GROUPS AND ORGANIZATIONS WITH THE SAME NONPROFIT PURPOSES.

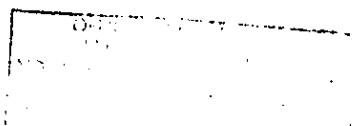

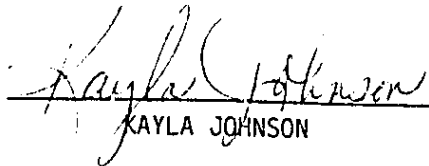
