The undersigned, acting as incorporators of a corporation under the "non-profit Corporation Act" of the state of Florida, adopt the following articles of incorporation

ARTICLE I

The name of the corporation shall be: EL SHADDAI WORD MINISTRIES Inc.

The Initial street address in the state of Florida of the of the initial principal office of the corporation is:

ARTICLE II

The period of duration of EL SHADDAI WORD MINISTRIES INC. is perpetual.

ARTICLE III

The purpose for which this corporation is organized is to operate exclusively for religious, charitable, and educational purposes as well

qualify it as an exempt organization under section 501 (c)(3) of the internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws, including for such purposes, the making of distributions to organizations qualifying as tax exempt organization under that code. The corporation is empowered to hold any property, or any undivided interest therein, without limitations as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as in the judgement of the directors will best promote, the purpose of the corporation, without limitation, except such limitations, if any as may be contained in the instrument under which such property is received, these Articles of Incorporation, the Bylaws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Non-for-Profit Corporation Law.

\*To educate, ordain and license apostles, prophets, eveangelists, pastors and some teachers for the edifying of the body of Christ. Train others to be licenced in ministries in which office he/she is called.

To operate an Evangelistic Ministry ,teach, counsel,and minister the Gospel of Jesus Christ according to the Holy Bible and to include every form of media, radio, television, newsletters, and publications and to conduct seminars and religious training. Street Ministries, Singles Ministries, Prison Ministries and establish Churches and missions.

Ministries , Missions and Outreaches will be umberllaed under EL SHADDAI WORD MINISTRIES charter.

**ARTICLE IV**  
**POWERS AND PROHIBITED TRANSACTIONS**

*In addition to the powers authorized by law, the corporation shall have the power to lease, acquire, either by deed, gift or purchase, any real or personal property and to mortgage, sell or otherwise encumber any such real or personal property when such action is deemed to be in the best interest of the corporation as defined in it's stated purposes as a christian organization.*

*The corporation is prohibited from engaging in any activities prohibited by Section 617.0105, Florida Statutes are not to permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States Internal Revenue Law.*

**ARTICLE V**  
**DEDICATION OF ASSETS**

*The property of this corporation is inevocably dedicated to religious, charitable, and educational purposes and no part of the net income or assets of this corporation shall even inure to the benefit of any director, offices or member thereof.*

**ARTICLE VI**  
**MEMBERSHIP**

*Membership will be open to all people. In order to become a member of the ministry one must confess Jesus Christ as his or her Lord and Saviour and embrace the christian faith . Accept as true the religious intents and techniques of El Shaddai Word Ministries Inc. Declare allegiance to the ministry and agree to support and conform to its rules and regulations as duty and property adopted and promulgated.*




