AMENDMENT TO THE ARTICLES OF INCORPORATION OF GRAND CAY HOMEOWNERS ASSOCIATION, INC.

The original Declaration of Covenants, Restrictions and Easements for Grand Cay at PGA National is recorded in Official Records Book 8821 at Page 521 of the Public Records of Palm Beach County, Florida.

As used herein, words <u>underlined</u> are added and words hyphened through are deleted.

Article VIII(A) of the Articles of Incorporation shall be amended to read as follows:

The affairs of this Association shall be managed by a Board of not less than three (3) nor more than seven (7) directors (the "Board of Directors"), who need not shall be Members of the Association or the spouse (or the equivalent of a spouse) of a member, such number of Directors to be determined by the Board of Directors, from time to time.
