A NON-PROFIT CORPORATION

Pursuant to the provision of the Nonprofit Corporation Act section 617.0202, Florida Statutes, the undersigned incorporator hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is IGLESIA CRISTIANA NUEVA VIDA, INC. (New Life Christian Church, Inc.).

ARTICLE II

The principal place of business and mailing address of this ration shall be:
