

ARTICLES OF INCORPORATION
OF
UNITED CHRISTIAN ACADEMY OF SARASOTA, INC.

The undersigned hereby subscribe to these Articles of Incorporation to form a corporation not for profit under the laws of the State of Florida.

I.

The name of the corporation shall be UNITED CHRISTIAN ACADEMY OF SARASOTA, INC. Its principal office and its mailing address shall be 4411 Bee Ridge Road, Suite 182, Sarasota, Florida 34233.

II.

This corporation is organized for the purpose of owning and operating one or more Christian schools in Sarasota and in other areas of Florida; to engage in activities which are necessary, suitable, or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, this corporation will not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code. The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code.

III.

The method of election of directors of this corporation shall be as set out in the bylaws.

IV.

The date of commencement of corporate existence shall be the date these Articles have been filed with the Department of State; the term for which the corporation is to exist shall be perpetual. In the event of dissolution of the corporation, no part of the corporation's earnings or assets shall inure to the benefit of any of its members; the residual assets of the corporation shall be distributed to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code or to the federal, state or local government for exclusive public purpose.

V.

The street address of this corporation's initial registered office is 4411 Bee Ridge Road, Suite 182, Sarasota, Florida 34233, and the initial registered agent at that address is Elihu Brayboy.

VI.


