

### FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF

Pursuant to Sections 617.1001, 617.1002, and 617.1006, Florida Statutes. WEST END PROFESSIONAL PARK PROPERTY OWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the "Corporation"), hereby adopts the following First Amendment to its Articles of Incorporation (the "First Amendment").

- 1. The name of the Corporation is **WEST END PROFESSIONAL PARK PROPERTY OWNERS ASSOCIATION, INC.**
- 2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

The name of this corporation shall be LAKE LILLY PROFESSIONAL CENTER PROPERTY OWNERS ASSOCIATION, INC. (the "Association") and its principal office address is c/o Heller Bros. Groves, 306 South Ninth Street, Winter Garden, FL 34787.
