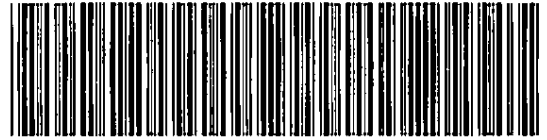

AMEND: (Rename) Article I: Citrus County Sheriff's Foundation, Inc.

AMEND: Article V. A. Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of not less than four (4) persons. Two Board members shall be appointed by the Sheriff of the Citrus County Sheriff's Office.

The Directors shall serve for a term of one (1) year until the annual meeting of members. The Sheriff may reappoint his prior appointed positions to serve consecutive terms with no limitations. The annual meeting shall be held in Citrus County, Florida in the month of January. Any Director shall be removed with cause by a majority of all votes of the Board of Directors or by personal resignation. The President shall appoint the Chair of all committees. Committees will be designated by the Board of Directors. The Board of Directors shall designate terms and duties of the committees.

AMEND: Article VI: A. Directors shall receive no compensation for their services on the Board of Directors. This shall not prevent the Corporation from reimbursing any Director for expense(s) actually and necessarily incurred in the performance of his/her duties as Director, when such expenses are authorized by the Board of Directors for the purposes of the Corporation.
