The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

### ARTICLE I: NAME

The name of the corporation is INFANTS' and CHILDRENS' AIDS RESEARCH and TREATMENT FOUNDATION, Inc.

### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 3067 East Commercial Blvd., Ft. Lauderdale, FL 33308.

### ARTICLE III: PURPOSE

The purpose is to fund HIV and AIDS research and treatment for infants and children.

#### **ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

#### **ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office and agent of the corporation is Ronald Sookdar, M.D., 3067 East Commercial Blvd., Ft. Lauderdale, FL 33308.

#### **ARTICLE VI: INITIAL BOARD OF DIRECTORS**

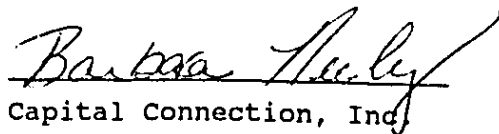
## **ARTICLE X: AMENDMENTS**
