**ARTICLES OF INCORPORATION**  
**"THE GREAT DAYTONA REEF" INC.**

*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.*

**ARTICLE I**  
**Name**

The name of the corporation shall be "THE GREAT DAYTONA REEF" INC.

**ARTICLE II**  
**Principal place of business and mailing address**

The principal place of business and mailing address of this corporation shall be. 1635 S. Ridgewood Avenue, South Daytona, County of Volusia, State of Florida 32124

**ARTICLE III**  
**Purpose(s)**

This corporation, as described in the Internal Revenue Code Subsection 501(c)(3), is organized and operated exclusively for charitable and/or scientific purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, no substantial part of the activities of which is carrying on propaganda, or otherwise attempting, to influence legislation (except as provided in Internal Revenue Code Subsection 501(h)), and which does not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

The primary activity of this corporation is to fund marine research and development coordinating with the efforts of already existing nonprofit and municipal organizations. The initial project to be funded by this corporation will be the construction, and any related scientific research, of artificial reefs off the shores of Volusia County in the State of Florida through any municipal organization permitted by the Army Corps of Engineers South Atlantic Jacksonville District to do such construction.

The secondary activities of this corporation are as follows. assisting in the relocation and employment of individuals who are poverty stricken and/or homeless, working with disadvantaged youths and other related charitable activities

Within the limitations set forth in this Article, this corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States or any of its possessions, the State of Florida or any other state

**ARTICLE IV**

**Limitation of corporate powers**






