RE: Addition of new trustee and removal of trustees who moved out of state

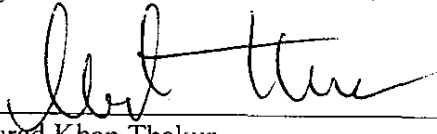

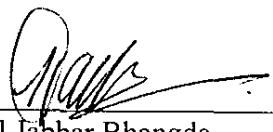

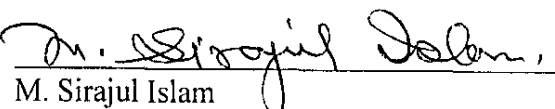
