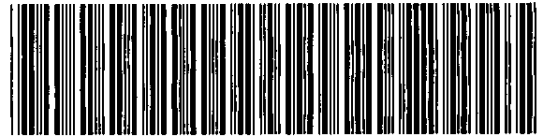

**ARTICLES OF INCORPORATION**

**(A Florida Non-profit Corporation)**

**ARTICLE I. NAME**

The name of this corporation shall be ISLAMIC CENTER OF OSCEOLA COUNTY, INC., whose address is 2417 North Central Avenue, Kissimmee, Florida, 34741.

**ARTICLE II. COMMENCEMENT & DURATION**

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual, unless it is hereafter dissolved according to law.

**ARTICLE III. PURPOSE**

This corporation is being formed for the purpose of engaging in the transaction of any and all activities permitted under the laws of Florida and the United States of America.

This corporation is irrevocably dedicated to and operated exclusively for non-profit purposes; and no part of the income or assets of the corporation shall be distributed to, nor inure to the benefit of any individual.

**This corporation is being formed:**

- 1. To practice Islam according to the commands of Allah Subhana watawala and the Sunnah of Prophet Mohammed (Peace be upon him) in the ways of Sunni principles.**
- 2. To purchase land, construct and manage the Masjid for Sunni Muslims of the community.**
- 3. To own and manage a cemetery for the Muslims of the community.**
- 4. To operate religious school for the Muslim children of the community.**
- 5. To convey the message of Islam to the people of other faiths, so that better understanding and harmony exists in the community at large.**
- 6. To establish the work of dawa as done by Tabligh Jamat.**
- 7. To make contributions to other Islamic organizations both here and abroad following rules and regulations of USA and the country where the contributions are sent.**

#### **ARTICLE IV. MEMBERSHIP**

**Any person who agrees to be bound by these Articles of Incorporation, the corporate Bylaws, and any rules and regulations which the Board of Trustees may from time to time adopt is eligible and qualified for membership in this corporation.**

**The corporate Bylaws may provide the Board of Trustees further discretionary powers relating to the admission of members.**

**Members shall be:**

- 1. All practicing Sunni Muslims will be the natural members of this corporation.**
- 2. To be a member, one has to believe and practice Islam according to the commands of Allah Subhana watawal and the Sunnah of Prophet Mohammad (Peace be upon him).**
- 3. Work for and participate in regular activities.**
- 4. The members will participate in all the programs of dawa as conducted in the Masjid.**
- 5. The members will use facilities of the corporation with the sole objective of practicing Islam.**
- 6. The members will abide by the laws of the country (USA), and must not involve in activities that defame Islam and are considered anti-state.**

**ARTICLE V. MANAGEMENT**

- A. The powers of this corporation shall be exercised, its properties controlled, and its affairs and business conducted and managed by the Board of Trustees.**
- B. Any action required or permitted to be taken by the Board of Trustees, under any provisions of the law, may be taken without a meeting, if all of the trustees or at least two thirds of the Trustee shall individually or collectively consent in writing to such action.**

Such written consent shall be filed with the minutes of the proceedings of the Board of Trustees. Any such action by written consent shall have the same force and effect as if taken by at least two-thirds majority vote of the Board of Trustees. Any certificate or other document filed, under any provision of the law which relates to the action so taken, shall state that the action was taken by at least two thirds majority vote and written consent of the Board of Trustees in a meeting or without a meeting, and that these Articles of Incorporation authorize the Board of Trustees to so act. Such a statement shall be prima facia evidence of such authority.

- C. Any new project or projects, constructions of such projects, will be handled by the Trustee. Collecting of funds and spending of those funds will be handled jointly by the Trustee and the finance secretary. Selection of project related architect, engineers, builders, etc. will be done by the Trustee.
- D. The Imam can be only hired and terminated by the Trustee.

#### **ARTICLE VI. SHURA**

- A. The Masjid affairs will be handled by a fourteen member Shura committees. The Shura will function for three year but if the Trustees are satisfied with the performances of the Shura then the term can be extended thereafter by the Trustee for whatever additional years they decide.

- B** Members of the Shura will have different responsibilities as mentioned below. Two members will handle each department. All major decisions will be taken in joint Mashwara of the members of the entire Shura. At least two thirds majority is needed for a decision. individual committee may take their own decision as per guidelines of each committee.
- C.** All members of the Shura should bear in mind the basic objectives of Masjid Taqwa which are to understand the responsibilities of each and every Muslim for which Allah Subhana wa tawala has created us as the Ummati of Muhammad Sallal lahu Alaihe wa Sallam, practice the deen according to the Sunnah of Rasulullah Sallal lahu alai he wa Sallam, convey the message of Islam to the mankind; hold strong to the objectives and practice them in daily life.
- D.** All members of the Shura must adhere to the constitution of the corporation, show respect to one another and agree to follow the decision of the mashwara. Anyone violating those guidelines and refusing to accept the decision of the mashwara will be removed from the committee, if requested by the other members of the Shura by the Trustee. In case of dispute the Trustee may dissolve the Shura and form a new Shura.
- E.** Under no circumstances, the members of the Shura will interfere,

criticize, or withhold the facilities of the Masjid for the use by the  
Jamat that will visit, or stay at the Masjid. By every means the  
Members of the Shura will help the Jamats to perform their amal and  
duties while in the Masjid.

- F. Unity amongst the brothers is the fundamental objective and should be promoted at any cost in favorable and unfavorable conditions.**
- G. Quran, Sunnah and the Shariah guidelines must be the driving force for everyone. All the activities must be planned keeping them in mind.**
- H. The Trustee may take opinion of the members of the corporation including suggestive names for the members of the Shura or may choose of their own in their own Mashwara.**
- I. All the mashwara will be conducted according to the attiquette taught by the scholars of Tabligh Jamat.**
- J. The day to day matters of the Masjid will be conducted by the Shura as outlined below.**
- K. One person of each committee will be the responsible brother. He will have another person as co-worker. To fulfill the department responsibilities they may request the help of other members of the Masjid with written consent of the Faisal of the Trustee of that time.**
- L. The Ameer of the Shura will be selected by the members of the**

Shura, who will serve for a period of six months. No same person should be selected as responsible brother twice in the same year.

- M. Once every three months the Shura, will meet the Trustee to discuss any program or problem of the Masjid. The Faisal of the Trustee of that month will conduct the mashwara. The mashwara will approve or disapprove any such program and discuss the problems to resolve them.
- N. If any member of the Shura resigns or leaves then the remaining members will suggest 2-3 names for each vacancy to the Trustee, who will select the new member from those names.

#### **ARTICLE VII. DONATION**

No donations will be accepted with any conditions that are contrary to the principles of the corporation. The Trustee or the committees may reject donations that may not come from halal sources.

#### **ARTICLE VIII. BOARD OF TRUSTEES**

- A. There will be five members in the Board of Trustees who will be Sunni Muslim. The names of the Trustees:
1. Ahmed Aidoo
  2. Ashiqur Rahman
  3. Murad Khan Thakur
  4. Saaed Ahmad
  5. Siraj ul Islam

- B. The Trustees are for life. If any of the Trustee dies, resigns or becomes totally disabled, then a majority of the remaining members of the Trustee shall select a replacement Trustee from among the brothers who has spent at least forty days in Jamat. If resignation letter is submitted then the Faisal of the month will call the mashwara of the Trustee to accept or reject such resignation.**
- C. Every six months or during each mashwara the existing Faisal will select new Faisal with the opinion of the Trustee.**
- D. If there is disagreement in any matter, the decision of a two-thirds majority of the Trustee will be final. In case of dispute the matter should be submitted in writing to Dewsbury Markaz Shura in England. The decision of that Shura will be final.**
- E. A Trustee can be removed if one creates division, friction in the community, spreads allegations against other Trustee, fails to follow the Mashwara, talks against the efforts of dawa, the aims and objectives of the corporation, undermines other Trustee, disrespects the members of the community, works against the aims and objectives of the corporation, then a majority of Trustees can expel that Trustee and select a new Trustee.**

**FUNCTIONS OF COMMITTEES:**

**MEMBERS OF MAINTENANCE COMMITTEE**

- a. The members will look after all the issues pertinent to keeping**

**the Masjid in good condition, for example: repair work, cleanliness, pest control, landscaping, etc.**

**b. The members will hire a full-time or part-time person for keeping the Masjid/Kitchen/Toilet/Wodu place in good and neat and clean state.**

**c. The members will hire the landscaper and handi-man for all of the repair work as needed.**

**d. The members will look after the air conditioning system, all electric equipment, sound system, monitoring system, etc.**

**e. The members will maintain the stoves in the kitchen, refrigerators, cooler, and water fountain for smooth running of the kitchen for Shob-e-junna and jamats cooking, Ramadan Ifteri Shehri, etc.**

**f. The Masjid premises will be kept clean by the appropriate person/persons as decided by the members.**

**MEMBERS OF EDUCATION COMMITTEE**

**i. The members in consultation with the Imam and Moulana A. R. Patel or his successor will select the syllabus for the boys and girls Quranic class and Islamic Education in the Masjid.**

**ii. The members will encourage the community members to send their children to the respective classes.**

**iii. The members will arrange adult Quranic class to teach and learn proper recitation of the Quran.**

- d. The members will arrange classes for the new Muslims.
- e. The members will arrange Quranic Tafsir classes conducted by the Imam and the scholar of the Masjid only. No outsider or person who is not an aleem and not employed by the Masjid should conduct Tafsir classes.
- g. The members will collect the fee with proper receipt from the students, if the committee decides to collect such fee, and give the collection to the Finance Committee with proper documentation.

#### **MEMBERS OF SOCIAL ACTIVITIES COMMITTEE**

- a. The members will arrange the Islamic Events allowed by the Shariah, in consultation with the Imams of the Masjid.
- b. The members under the guidelines of Ikram ul Muslimeen will look after the well-being of the community members.
- c. The members will encourage the Muslims to understand all the citizens of our country (USA), establish good communication with them to reflect Islamic value, provide necessary help at the time of need.
- iv. The members will arrange Iftar, Sehri and dinner in Ramadan.
- v. The members will make necessary arrangements for both the Eid, Khotme Quran and Islamic events suggested by the Imams and the Trustee.

vi. The members will not interfere with the Shab-e-jumma and any Tablige program that will take place in the Masjid.

vii. No events should be arranged by the members where there will be mixed gathering.

#### **MEMBERS OF YOUTH COMMITTEE**

a. Youth are our future flag bearer of Islam. Accordingly they must be understood, welcomed, respected, and guided.

b. To promote communication between the young generation and the community at large the members will give suggestion to other committees and the Trustee.

c. The members will encourage the young generation to participate in regular Salah, all Tabligh program, going out in jamat, and in all other programs of the Masjid.

d. Once every six months the members will arrange the gathering of the youth in the Masjid. The Ulama or the brothers involved in dawa work and a member of the young generation will give talk to those gatherings.

e. The problems related to the youth will be handled by the members with utmost care and understanding. Every effort must be made to keep the youth attached to the Masjid and the deen at large.

f. Sensitive issues should be brought by the members for discussion at Trustee level for advise and resolution without creating

**division amongst the youth.**

**g. Sports and sports events related to the youth will be handled by the members.**

**viii. Under the guidelines given by the Moulana the girls gathering can be arranged as per his suggestion by the members.**

#### **MEMBERS OF FINANCIAL COMMITTEE**

- a. All the financial activities excluding expansion projects and new projects will be handled by the financial members.**
- b. All collections (donation for the Masjid, Zakat, Sadqa and contributions for construction and expansion) will be deposited by the members to respective accounts.**
- c. Opening of the safe boxes will be done by the responsible brother of the committee in presence of one of the trustee or Imam of the Masjid. The money will be counted and recorded under different heading in appropriate bookkeeping book and signed by above persons.**
- d. The salaries, all monthly expense checks will be issued by the members. Two members and one Trustee will be the signatories of the accounts. Every check MUST BE SIGNED by two signatories.**
- e. Any expense, other than salaries and utility bills, above \$500.00 (five hundred dollars) must be approved by the mashwara of the Trustee and Faisals of different committee. Request for**

money by any committee has to be approved in above mashwara.

f. If the financial committee members fail to follow the guidelines then the committee will be dissolved by the Trustee and the Trustee will handle the financial matter until new members are selected by the Trustee.

g. Once a year all the accounts should be presented to the Trustee in presence of the Shura. Any fund handled by the Trustee will be presented in that Mashwara.

#### **MEMBERS OF KHIDMA COMMITTEE**

a. The members will arrange the cooking for Shab-e-juma, organize and serve on each Thursday.

b. The members will arrange food and serve on any special events, like scholars visiting us, youth gathering, etc.

c. The members will coordinate and purchase for Shab-e-juma, Ijtema, and all special events.

d. The members will help the social service committee to carry out their program.

#### **ARTICLE IX. PRINCIPAL OFFICE & REGISTERED AGENT**

The address of this corporation's principal office and the address of this corporation's registered office shall be: 2417 North Central Avenue, Kissimmee, Florida, 34741.

The name of the individual who shall serve as this corporation's registered agent at that address is: Siraj ul Islam.

#### **ARTICLE X. INCORPORATIONS**

#### **ARTICLE XI. BYLAWS**

Corporate Bylaws will be hereinafter adopted by the Board of Trustees. The corporate Bylaws may be amended or repealed, in whole or in part, by the Board of Trustees in the manner provided therein, provided that they are not inconsistent with the provisions of these Articles of Incorporation. Any amendments to the corporate Bylaws shall be binding on this corporation's members.

#### **ARTICLE XII. AMENDMENTS**

Amendments to these Articles of Incorporation may be proposed by a member of the Board of Trustees and adopted by the majority of the members of the Trustee in their mashwara. Such amendments will become a part of the Articles of Incorporation of Islamic Center of Osceola County, Inc.

#### **ARTICLE XIII. LIMITATION**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. None of the properties of the corporation can be used as collateral for any reason whatsoever either for individual or corporation need. Any loan or financing that involves interest must be avoided by all means even if it

is Sharia compliant. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation except as otherwise provided in Section 501(h) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### **ARTICLE XIV. DISSOLUTION**

Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provisions of the payment of all of the liabilities of the corporation, transfer all of the assets of the corporation exclusively to an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 so long as such organization shall use the assets for Islamic purposes as per Sariah. Any such assets not so disposed of for any reason shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for Islamic charitable, Islamic educational, Islamic religious,

or to such Islamic organization or organizations as said court shall determine, which are organized and operated exclusively for such purpose.

#### **ARTICLE XV. ACCOUNTS AND BOOKS**

The Board of Trustees from time to time shall determine whether and to what extent, and at what times and places and under what conditions and regulations, the accounts and books of this corporation, or any of them, shall be opened to the inspection of the Shura, and no representative of the committees shall have the right to inspect any account or document of this corporation except as conferred by a statute, the Bylaws, or authorized by the Board of Trustees.

#### **ARTICLE XVI. NONSTOCK BASIS**

The corporation is organized and shall be operated on a nonstick basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock or other certificate or writings evidencing an ownership or proprietary interest in the corporation.




