ARTICLES OF INCORPORATION

OF

SS JUL -7 AMII: 10 TALLANASSIE SISTATE SHORTLINE LAKE ESTATES HOMEOWNERS ASSOCIATION

OF SANTA ROSA BEACH, INC.

(a Florida corporation not-for-profit)

In compliance with the laws of the State of Florida, the undersigned does hereby certify:

ARTICLE I

NAME

The name of the corporation is SHORTLINE LAKE ESTATES HOMEOWNERS ASSOCIATION OF SANTA ROSA BEACH, INC., hereinafter referred to as the "Association".

ARTICLE II

REGISTERED AGENT

The initial registered agent of the Association and address is:

By executing these Articles, the Registered Agent hereby accepts his appointment and agrees to act in this capacity and to comply with the provisions of the Florida Statutes governing same.

ARTICLE III

PURPOSE AND POWERS

The Association does not contemplate pecuniary gain or profit to its members. Its specific purposes are to provide for the maintenance, preservation and architectural control of certain residential lots or residences ("improved lot") and common property located within various residential developments or subdivisions (the "subdivisions") of SHORTLINE LAKE ESTATES in Walton County, Florida, all for the mutual advantage and benefit of the members of this Association who shall be the owners of the improved lots, and to promote the health, safety and welfare of the owners of the improved lots in the above-described property and any additions thereto as may hereafter be brought within the jurisdiction of this Association. For such purposes, the Association shall have and exercise the following authority and powers:

- (a) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in those certain declarations of easements, covenants and restrictions for the subdivisions (the "Declarations") now or hereafter recorded in the public records of Walton County, Florida, as amended from time-to-time;
- To fix, levy, collect and enforce payment by any lawful means all charges and assessments pursuant to the terms of the Declarations, to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association;

- (c) To acquire, by gift, purchase or otherwise, own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association, in accordance with the Declarations;
- (d) To borrow money and, with the assent of the members in accordance with their respective Declarations, to mortgage, pledge or hypothecate any and all of its real or personal property as security for money borrowed or debts incurred;
- (e) To dedicate, sell or transfer all or any part of the common property of the subdivisions in accordance with their respective Declarations to any public agency, authority or utility for such purposes and subject to such conditions as may be approved by the members;
- (f) To act as purchasing agent for goods and services for the Association and for the benefit of the members of the Association; and
- (g) To have and to exercise any and all powers, rights and privileges which a corporation not-for-profit organized under the laws of the State of Florida may now or hereafter have or exercise.

ARTICLE IV

MEMBERSHIP

The objective of this corporation is the improvement of the quality of life of the residents of SHORTLINE LAKE ESTATES who are the members of this Association, by providing for the common property to be owned or managed in accordance with the provisions of the Declarations.

Every person or entity who is a record owner of a fee or undivided fee interest in any lot or improved lot shall be a member of the Association. The foregoing is no, intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any lot which is subject to assessment by the Association.

ARTICLE V

VOTING RIGHTS

The Association shall have two (2) classes of voting membership, as follows:

<u>Class A.</u> Class A membership and voting rights shall be the same as set forth in the Declarations.

<u>Class B.</u> Class B membership and voting rights shall be the same as those set forth in the Declarations.

Unless specified otherwise in the Declaration for a particular subdivision, the developer thereof shall to deemed to be a Class B member and the purchasers of the lots in that subdivision shall be Class A members.

ARTICLE VI

BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of Directors, who shall be members of the Association; provided, however, that any Director elected by the Class B membership of a subdivision need not be a member of this Association. The number of Directors of the Association shall be three (3) persons or more as long as the total number of Directors is an odd number. The names and addresses of the persons who are to act in the initial capacity of Directors until the selection and qualification of their successors are: Directors shall by elected by the BY-LAWS of the Association.

ARTICLE VII

TERM OF EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved in accordance with the provisions herein contained or in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of State of the State of Florida.

ARTICLE VIII

DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than seventy-five percent(75%) of each class of members. Upon dissolution of the Association, the assets of this Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created or for the general welfare of the residents which are then managed by the Association. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to similar purposes.

ARTICLE IX

OFFICERS

Subject to the direction of the Board of Directors, the affairs of this Association shall be administered by its officers, as designated in the Bylaws of this Association. Said officers shall be elected annually by the Board of Directors. The names and addresses of the officers who shall serve until the first annual meeting of the Board of Directors are:

BYLAWS

The Bylaws of this Association shall be adopted by the first Board of Directors, which Bylaws may be altered, amended, modified or repealed by a majority of the Directors of at any duly called meeting of the members of this Association in a manner provided for in the Bylaws.

ARTICLE XI

AMENDMENTS

The members of the Association reserve the right to amend or repeal any of the provisions contained in these Articles of Incorporation or any amendments hereto, provided, however, that any such amendment shall require the assent of seventy-five percent (75%) of the entire voting membership and on such other terms as required by the Declaration.

ARTICLE XII

SUPREMACY

These Articles and the Bylaws are subject to the various Declarations, and in the event of a conflict, the applicable Declaration shall govern. In the event of a conflict between the Articles and Bylaws, the Articles shall govern.

ARTICLE XIII

INDEMNIFICATION

This Association shall indemnify any and all of its Directors, Officers, employees or agents, or former Directors, Officers, employees or agents to the full extent permitted by law. Said indemnification shall include but not be limited to the expenses, including the cost of any judgments, fines, settlements and counsel's fees actually and necessarily paid or incurred in connection with any action, suit or [roceeding, whether civil, criminal, administrative or investigative and any appeals thereof to which any such persons or his legal representative may be made a party or may be threatened to be made a party by reason of his being or having been a Director, Officer, employee or agent as herein provided. The foregoing right of indemnification shall not be inclusive of any other rights to which any Director, Officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.
