Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation edopts the following amendment(s) to its Articles of Incorporation:

ARTICLE I. NAME: Florida Gulf Coast School of Theology & Seminary, Inc.

ARTICLE II. PRINCIPLE PLACE OF BUSINESS & MAILING ADDRESS

438 East Lemon Street, Tarpon Springs, Florida 34689

ARTICLE III. PURPOSE(S):

Addition to original, as follows: Florida Gulf Coast School of Theology S Seminary, Inc. is organized exclusively for religious, charitable, scientific, literary, and educational purposes within the meaning of of section 501 (c)(3) of the Internal Revenue Code of 1986 or the CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

Notwithstanding any other provision of these articles, this organization SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(c) (3) of the Internal Revenue Code of 1985 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV. MANNER OF ELECTION OF OFFICERS:

The manner in which the Directors are elected or appointed is as follows: Florida Gulf Coast School of Theology & Seminary, Inc. shall have its affairs governed by a BOARD OF GOVERNORS. The by-laws shall state the manner in which members shall be appointed.

ARTICLE V. LIMITATIONS OF CORPORATE POWERS:
