# ARTICLES OF INCORPORATION OF PARADISE OAKS PROPERTY OWNERS' ASSOCIATION

We, the undersigned acting as incorporators of a non-profit corporation under Chapter 619 of the Florida Statues, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

NAME -- The name of this corporation is PARADISE OAKS PROPERTY OWNERS ASSOCIATION, INC.

#### ARTICLE II

PURPOSE -- This corporation is organized to further promote the common interest of property owners in the area known as PARADISE OAKS, and specifically described in Exhibit "A" attached hereto. In furtherance of this purpose, this corporation may exercise all powers and privileges set forth in the Paradise Oaks Protective Covenants as recorded in Official Records Book 270 , pages 1120-1135 , of the public records of Washington County, Florida, as it may be amended from time to time. Additionally, this corporation shall have and exercise any and all powers, rights, and privileges which a nonprofit corporation organized under Chapter 617, Laws of the State of Florida, by law may now or hereafter have to exercise.

#### ARTICLE III

QUALIFICATION OF MEMBERS AND MANNER OF ADMISSION -- Each owner of a building site of the property described in Exhibit "A" attached hereto shall automatically be a member of this Association upon the recordation of a plat designating such building site and including the property described in Exhibit "A" attached hereto. The qualifications set forth above shall be the only qualifications for membership and neither the Board nor the Association shall have the power to impose additional membership requirements.

#### ARTICLE IV

DURATION -- The period of duration of this Association shall be perpetual.

#### ARTICLE V

#### ARTICLE VI

OFFICERS AND ELECTION OR APPOINTMENT -- The affairs of this corporation are to be managed by a Board of Directors composed of not less than three persons nor more than five persons, who need not be members of the Association. The first Board of Directors shall have three members; and in the future the number will be determined from time to time in accordance with the provisions of the bylaws. The Board of Directors shall be elected annually commencing one year from incorporation.

#### ARTICLE VII

OFFICERS -- The officers of this Association shall be a President, Secretary, and Treasurer, each of whom shall be elected by the Board of Directors following the election of the Board of Directors by the members of the Association. The Board may elect themselves or other persons to fill such offices. Any two or more offices may be held by the same person.

#### ARTICLE X

BYLAWS -- The bylaws of this Association may be made, altered, or rescinded at any annual meeting of the Association, or at any special meeting duly called for such purpose, on the affirmative vote of 51% of all the members present and voting, each member having one vote for each building site owned by such member. There shall be no votes by proxy. Any owner may designate that the occupant of a home shall be the member in lieu of such owner. No owner shall be entitled to vote unless such member has paid all of his dues and other charges or assessments as shown on the books of the Association,. When any property within Paradise Oaks is owned of record in joint tenancy or tenancy in common, or in any other manner of joint or common ownership, such owners shall collectively by entitled to one vote per building site, which vote shall be exercised by the consent of a majority of the owners of record of such building site. The owner of two or more building sites, shall nevertheless be entitled to one vote per building site. The initial bylaws of the Association shall be made and adopted by the Board of Directors.
