

ARTICLE X. AMENDMENTS

Amendments to these Articles of Incorporation shall be made in the following manner:

(Section a and Section b Remain Unchanged)

(c) At such meeting, a vote of the members entitled to vote thereon shall be taken on the proposed amendment. The proposed amendment shall be adopted upon receiving the affirmative vote of a majority of the votes of all members of the Association entitled to vote thereon seventy-five percent (75%) of the voting interests of the Association present (in person or by proxy) and voting at a duly noticed meeting at which a quorum is present.
