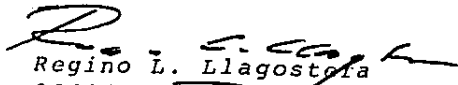

Section 617.0803, Florida Statutes, requires that the board of directors never have fewer than three directors.

To encourage the development of democracy through cultural and political activities with Cuba.

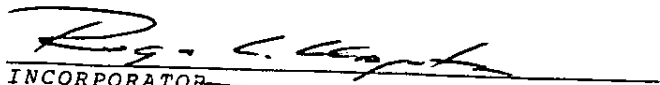

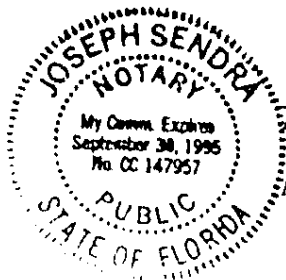
