WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit under the following proposed Charter:

ARTICLE I

The name of the corporation shall be MIRACLE TEMPLE OUTREACH SERVICE CENTER, INC., and it is to have its main office located at 2101 Southwest 57th Avenue, Hollywood Hills, Florida 33023.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The general nature and object of this non-profit corporation shall be to meet the insufficiency of not only the youths of the neighboring communities, but also to the family unit. The object is to infuse a healthy self-esteem and a positive influence for the betterment of life.

#### ARTICLE VIII

The Articles of Incorporation of this association may be altered, amended or rescinded by three-fourths affirmative vote of the members present at any meeting of the Board of Trustees, provided that the proposed amendment, alteration or rescission has been announced and submitted at the preceding meeting.

### ARTICLE IX

The corporation shall have the power to have, hold, purchase and possess, enjoy and receive by gift or demise or otherwise, real and personal property, chattels, Moines, annuities and effects, to erect a building or buildings and keep the same in repair, and to do contract and be contracted with, to rent, sell and otherwise dispose of or mortgage its real and personal property as it may desire or deem to be for its best interest and to do anything necessary or expedient for the carrying out of the object of this corporation.

### ARTICLE X

The amount and value of the real estate which this corporation may hold and own shall not exceed one million dollars, and the corporation shall not be empowered to become indebted in an amount greater than five hundred thousand dollars, which amount shall not be greater than two-thirds of the value of the property of the corporation held at that time.

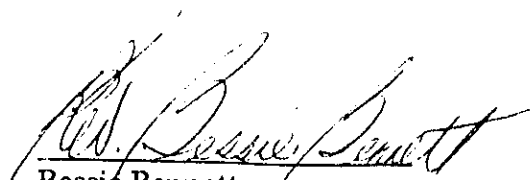

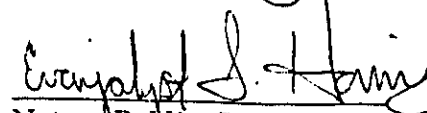

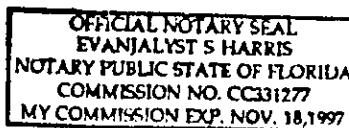
