## ARTICLES OF INCORPORATION

*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

### ARTICLE I

#### Name

The name of the corporation shall be:

Womens' Coalition for the Disadvantaged, Inc.

### ARTICLE II

#### Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III

#### Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

1. To assist the disadvantaged by providing free, general information of programs set up for their problems, and to direct them towards the right assistance.
2. To assist disadvantaged senior citizens by providing group housing for the homeless senior citizen and senior citizens on a low or fixed income.
  - a. Group housing providing (2) hot meals daily. As well as, transportation for medical services and general weekly excursions, and maid service for good housekeeping.
3. To assist the disadvantages by providing affordable housing to Section 8 recipients.

### ARTICLE IV

#### Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

All directors and associate directors have joined forces by contributing funds to the corporation which will be used to provide our specific purpose set forth in Article III. Directors will be in three categories:

Executive Directors - will manage all administrative operations.

General Directors - (8) will have voting power equal to 7.6925 - totaling 61.54

Associate Directors - (10) will have voting power equal to 3.846 - totaling 38.46

Elections of the executive directors will be decided by voting from the general directors and associate directors.

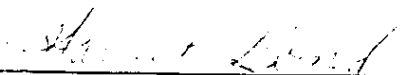

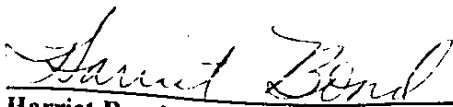

## ARTICLES AMMENDMENT

Womens' Coalition for the Disadvantaged, Inc. do hereby adopt the following provisions to be included in the Articles of Incorporation for this corporation. These provisions have been accepted by the Board of Directors and Members of this corporation who voted unanimously in favor of these additions. This vote was taken on November 21, 1996 which is the Date of Adoption for this ammendment. The Articles of Incorporation shall be ammended as follows:

- *Womens' Coalition for the Disadvantaged, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.*
- *No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof.*
- *No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.*
- *Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.*
- *Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to aa state or local government, for public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.*
